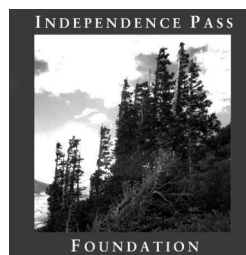

Winter Closure Gate of Hwy 82 to Lincoln Creek Rd



Ski For the Pass is a race/tour that is part of the Aspen Cup Nordic Series & is a benefit for the Independence Pass Foundation. Whatever your level of cross country skiing ability, join us this holiday season for a fun and beautiful race or tour from the winter closure gate on Hwy 82 east of Aspen to the Lincoln Creek Rd turnoff.

Course: This is a gradual uphill course from the winter closure gate to Lincoln Creek Rd. Distance is 7K (4.2 miles). Four classic tracks will be set. The course will not be groomed for skating.

Registration/Cost: Entry is \$15/individual, \$7/under 18, \$30/family (parents and children comprise a family). Payment is by CASH or CHECK only. Checks should be payable to "Ute Mountaineer" Registration is available at the Ute Mountaineer during regular store hours from January 23rd thru 4pm February 16. It is also available at the race start on race day from 8:30-9:30am. Mailed in registrations must be received by 2/16/19 4pm—Please send to: Ute Mountaineer, Attn: Ski For the Pass, 210 S. Galena St., Aspen, CO 81611.

Bib Pick-up: Bibs can be picked up race morning from 8:30-9:30am at the race start. There are NO TIMING CHIPS.

Aid Station: There will be one aid station at the Weller Lake trailhead with water & an electrolyte drink. At the Finish line there will be pastries and hot drinks available.

The Aspen Cup Nordic Series: is a recreational cross-country ski racing series held in the Aspen/Snowmass area that emphasizes FUN & fitness for all ages & abilities, racers & non-racers alike. The Ute Mountaineer, The Aspen XC Center, the Snowmass XC Center, Pitkin County and the City of Aspen are the main sponsors for the series.
